Who is complicit in crimes and has been expecting this email for 4 years since I warned him in October 2016. And because when Japan unifies under common law, well I kind of think they'd also like to know this story too. This isn't U.S. only.

Hey [REDACTED],

Thanks. I was going to take it a bit further with you, but I think you could be a key asset. And I need to use my bullets for smarter people, you're just a dumb worthless fuck.

You may not see this because you're so fucking evil but that's not my point, it's that you're stupid. Cc'ed and Bcc'ed on this email are military personnel running new hypergraph protocols for internet integrity. They see everything you dumb fucking cunt.

Attached are the emails you changed on Google Servers **and** on my account original which (We) recovered and I attach here as part of a criminal investigation.

What I would suggest [REDACTED] is this, to be cooperative as this unfolds:

- change your gmail account(s) passwords and add 2 factor
- backup locally and start keeping good records in between supporting baby-fuckers
- decide if you want to live in prison when maritime law hits or be with your family

5. As someone who has been in tune with truth and law for decades, I don't usually get involved too heavily in who the next President is. What I work on is finding evidence that can be useful and being genius level at putting things together. So that's what role I will play here. Oh and [REDACTED]. Did you really think I was so stupid for sending you the \$100 payment first? Good luck trying to erase that from the banks. Because when they knock on your door, that timestamp was running on QFS / NESARA / GESARA (let me Google that for ya)

You know what, can you see how I didn't even bother to copy your pals in crime [REDACTED] and [REDACTED] whom are already your stupid chosen fall guys in the past for these crimes? Correct, because then you'd have to **FORWARD** the email on to them. Choose wisely.
